#### Dear Friends:

It is an honor to represent Maine in the U.S. Senate. I am grateful for the trust that Mainers have placed in me and welcome this opportunity to share some key accomplishments for our state.

Last year, I secured more than \$500 million for 285 projects from Aroostook County to York County that will promote job creation, workforce training, and economic development; expand access to health care; improve public safety, infrastructure, and community resources; and protect our environment. To address the crisis of soaring inflation and high energy prices, I led efforts to provide \$2 billion in supplemental funds to the Low-Income Home Energy Assistance Program. In the new Congress that begins in 2023, I expect to be the Vice Chairman of the Appropriations Committee and will continue to champion investments to support Maine's communities and families.

Strengthening our economy and supporting good jobs remain a top priority. Along with the Governor and the rest of the Maine Delegation and the associations representing the lobster industry, I worked to protect our hardworking lobstermen and women by pausing for six years the onerous federal regulations that jeopardize our lobster fishery's very existence. Another ongoing threat to Maine's small businesses is the shortage of workers. That's why I led an effort to push the Administration to nearly double the number of H-2B visas that are critical to our hospitality industry. Additionally, when the Administration proposed to cut the construction of a destroyer to be built by Bath Iron Works, I restored this funding to protect Maine jobs and our national security.

When Maine Veterans' Homes announced last year that it planned to close its facilities in Caribou and Machias, I opposed that decision which would have had such a devastating effect on rural veterans and their families. I am glad that the decision was reversed, and I have secured \$3 million to help with upgrades to these facilities. My *AUTO for Vets Act* also became law, which will help disabled veterans maintain their independence by supporting the purchase of a new adaptive vehicle once a decade.

This past year, Congress demonstrated how effective it can be on behalf of the American people when both parties work together. A few of the bipartisan achievements that I was involved in include the *Respect for Marriage Act*, which will provide certainty to millions of loving couples in same-sex marriages while protecting religious liberties, and the *Electoral Count Reform Act*, which establishes clear guidelines for our system of certifying and counting electoral votes for President and Vice President.

No one works harder than the people of Maine, and I have honored that work ethic by showing up for every vote. During my Senate service, I have cast more than 8,500 consecutive votes, never having missed one. I remain committed to doing all that I can to address your community's concerns in 2023. ### Jared Golden Congress of the United States 2nd District of Maine

Dear Friends,

I hope this letter finds you safe and well. It's an honor to continue serving as your representative in Congress, and I take the responsibility very seriously. I appreciate the opportunity to update you on what I've been working on behalf of the people of the Second Congressional District.

In August, I voted for the *Inflation Reduction Act* because it represented a dramatic turnaround from misguided efforts to pass sweeping, ill-designed legislation that tried to accomplish too many things through budget gimmicks, setting up problematic fiscal cliffs in numerous programs and refusing to make the difficult decisions to allow for a fiscally responsible bill.

The *Inflation Reduction Act*, which was signed into law by the president, was fiscally responsible and targeted four key priorities: reducing our national debt and putting our country back on a more sustainable path, lowering the cost of prescription drugs, and making health care more affordable, investing in an all-of-the-above energy strategy to significantly increase oil, gas, and renewable energy production to lower energy costs for Americans, and cracking down on the tax avoidance of billion-dollar multinational corporations. This bill was the first major legislation in the last decade to use the reconciliation process to create a fiscally responsible budget to reduce deficits. The Congressional Budget Office estimated it would reduce deficits by approximately \$300 billion.

As a member of the House Armed Services Committee, I also helped pass the Fiscal Year 2023 National Defense Authorization Act, which among other things, included key wins for Bath shipbuilders, UMaine, and servicemembers and their families. For shipbuilders, the bill secured authorization for a third DDG-51 destroyer; established a new contract for up to 15 DDG-51 destroyers over the next five years, many of which will be built at Bath Iron Works; and included funding for shipyard infrastructure. The bill also authorized over \$25 million for defense research programs, including UMaine's large-scale manufacturing program. Finally, the bill authorized a 4.6% pay increase to help servicemembers and their families deal with rising costs due to inflation.

Additionally, at the end of 2022, Congress passed a spending bill to fund the government through September of 2023. The bill funds nearly \$27 million in funding for community projects across the Second Congressional District, a lifeline for our lobster industry that freezes any regulatory action for at least six years, and secures millions in additional funding for the Low Income Housing Energy Assistance Program (LIHEAP) to help Mainers heat their homes.

Regardless of the year, one of my top priorities is ensuring I'm accessible to you. My staff and I can help answer questions about and navigate federal programs; find resources in Maine; and resolve issues with Medicare, Social Security, the VA, and other federal agencies and programs. Dear Friends,

I've often thought that Maine is just one big small town connected by long roads. Well, in the past year or two, those roads have gotten steeper and bumpier as we dealt with an unprecedented pandemic and the resulting economic troubles.

As we faced the historic challenges, something impressive happened. We came together and lent a hand to our neighbors wherever we could to keep things running and spirits high.

Down in Washington, Congress tried to help Maine communities get through this struggle, so that our state would come out stronger. To do that, we put in the work and set some things into motion that are already helping Maine people. That's why you hired us, after all.

The pandemic made something we'd known for a while clear: those roads and networks that connect our big town needed repair, improvements, and expansion – from bridges to broadband. So, while Maine was uniting towards a common purpose, Congress came together to pass the *Bipartisan Infrastructure Law* – legislation that makes generational investments in physical infrastructure, broadband connections, harbors, and the energy grid. These efforts will lay the foundation for Maine's 21<sup>st</sup> century economy and make sure even the most rural areas aren't left behind.

Over the last two years, as we drove up and down our state, you couldn't help but see storefronts in trouble and prices rising as the economy struggled through a global recession. And again, while you focused your efforts on getting through the difficult times, Congress took meaningful action. We passed the *American Rescue Plan* in 2021, which enabled Governor Mills and the state of Maine to better meet the health and economic difficulties of the pandemic. At a critical moment it expanded healthcare efforts to confront COVID and invested in the state to keep the economy in far better shape than most others nationwide.

Congress didn't stop there. This year, we took even more concrete steps to cut costs, create jobs, and provide more affordable, cleaner energy. The bipartisan *CHIPS Act* will bring home the manufacturing of the technical components known as "chips" that are used in everything these days – from smartphones to microwaves to cars – and in doing so reduce prices and create good American jobs. We also passed the *Inflation Reduction Act (IRA)* to lower healthcare costs, allow Medicare to negotiate drug prices, and cut energy bills with new rebates for things like heat pumps and solar panels.

Beyond these major investments, we also passed vital legislation to improve the day-to-day lives of Maine people and Americans nationwide. On a bipartisan basis, we expanded health care for veterans exposed to toxins, strengthened protections for marriage equality, supported Ukraine as it fought off a bloody Russian invasion, secured our elections and the peaceful transfer of power, and delivered millions in federal investments to projects up and down our state.

So, as Maine worked to get through hard times, Congress took steps to support our state – and we're already starting to see brighter days ahead. I'm proud to have played a small part down here; it's a true privilege to listen to you, work with you, and build a brighter future for all the incredible people up and down the roads that connect our big small town. ## **Town Manager's Report**

Dear Washburn Citizens,

Once again it is time for me to think back over the year and let you know about all of the exciting ventures we have been involved in and working on. There has been a great deal of activity once again with a lot going on. Per usual, it looks like this upcoming year is going to be no different. We have a lot of new projects underway and we are excited about all of them.

The major items we tackled this past year were:

- Beginning January 1, 2022, we combined the Washburn and Wade Highway Departments. This has been a work in progress and a "learn as you go" process but it is working out well for both towns. We have a great crew that all work well together and as a team they got a lot accomplished for both towns.
- We constructed a new sand/salt shed that is a shared venture between the two towns. This building is large enough to hold approximately 2400 yards of sand/salt, more than we need for a year. There are still a few things the company needs to figure out and correct with the building, but it is proving to be a great asset for both towns. Along with the construction of this sand/salt shed was the clean-up at the Washburn Highway Garage and the entire property. The men have done a remarkable job with this both inside and out. Currently, there is still a small amount of sand in that location which will be cleaned up this summer.
- The Town of Washburn also purchased a new 2022 Chevrolet 5500 series plow truck to plow the streets in town. That too presents a few minor issues that we are working out, however, it still makes things a lot easier than using the larger trucks on the small side streets. This small truck will be able to be used year around for many different applications around town.
- The paving of our town streets and roads continues. We were able to finish Riverside South, Churchill, Clark, Garage Drive and the worst parts of the Cross Road. We will continue on with the paving again this year with a fairly extensive plan of improvements.
- With the Efficiency Maine rebates we continued with the purchase of more heat pumps for our buildings. We focused this time on the Recreation Department building where we installed 3 heat pumps and also purchased a hybrid electric hot water heater. These items have gone a long way in reducing our fuel costs for that building. Currently I am also working to secure funding for heat pumps to help with the heating costs at the highway garage.
- I applied for and received a FEMA grant that would cover 50% of the cost of a large generator that will run the entire municipal building. This has been paid for but has not yet been installed. The generator will be moved to the new municipal building once that building is completed.
- Once again, we have been able to keep our mil rate stead at just under 20. There was a bit of an increase in all homes due to the increase in the overall state housing sales which lowered our state ratio. If we allow the state ratio to fall, that results in our losing government funds. By increasing the overall value of homes we can keep that ratio at 100% allowing us to receive

100% of funds while also allowing the taxpayer to receive 100% of their homestead exemption. We will continue to make this a top priority.

- The upcoming new budget has many increases that include the usual heat, electricity, gas & oil cost increases. However, there is a portion that also pertains to increased salaries. In order to keep employees we must stay competitive with neighboring communities. This means taking an ongoing and comprehensive look at where we were and where we need to be financially. Also, this year's budget includes a fairly large increase in ambulance subsidy of approximately \$80,000. We anticipated this increase and were relieved when it was not as high as we expected. On another positive note, we experienced a surplus of unbudgeted revenues this past year so I am very confident that we can keep the mil rate where it is and continue to make improvements to our town.
- Last spring the Town of Washburn was awarded \$750,000 from Congressional District Spending funds through Susan Collins' office to go towards a new public safety building. This is an ongoing project. The new building will be located in the field across from the high school with land that is being donated to the town by the McCrum family. This building will house a new fire station, police station and town offices. This is still a work in progress as we are trying to reduce the building costs for each department. There will be more meetings on this project in the near future and we are doing our best to make sure that we create a building that is just right for the Town of Washburn at a cost that we can all afford.
- We are in the middle of a very large MDOT sidewalk project. This has turned into a much larger project than we had earlier anticipated, however, when it is completed our Main Street will be a much safer place for our pedestrians. With the new sidewalk project also comes the construction of a new parking lot between the library and the store. This is a much needed addition to Main Street as the angle parking will be gone and there will be only parallel parking. The new parking lot will go in this summer. I am currently in the process of securing funding to assist with the cost of this project. One way or another, we need to make this parking lot become a reality not only to ensure the safety of our residents, but to make the shopping experience in the town easier. The bidding process for the sidewalks will happen this summer with the majority of the work taking place in 2024.

That is an abbreviated summary of highlights and projects we have been working on. As always, I am humbled to be in this position and grateful for the support and guidance I receive throughout the year. I say it each time I write this letter but need to acknowledge the team of people I have working alongside me. Thank you for all of your continued hard work! I look forward to working for you again this year and I am so excited for the things to come.

## **Annual Report**

To the residents of Washburn,

Washburn remains very busy and continues to grow with new businesses coming into the community. Sadly, as a community grows so do the criminal actions. Our biggest complaints are the drug complaints, the thefts, and the traffic complaints. This year we had a total of 3,228 which was a little lower than last year which came in at 3,693. We are still trying to enforce the laws by not always giving a summons but by giving more warnings when we can. We continue to be short handed and have only Sgt. Chandler Cole and Officer Hunter Bellanceau and Reserve Officer Nathan Pitre. These officers have been able to cover shifts by utilizing being on call on the slower times of the shifts. They are doing an excellent job.

My goal in rural policing is to let the residents know that we are here to help. Public relations are a must have for the officers who serve in small towns. Stopping by at schools or stores and just checking in is something that I strive for all the officers to do. I see that type of practice happening with Officer Bellanceau and Sgt. Cole and Officer Pitre. These officers are very friendly and are a great asset to the Town of Washburn.

We slowly are able to see a less restrictive environment after all the covid 19 protocols have eased. We will never go back to the way things were, but we will eventually get back into being able to get together and have family gatherings and Birthdays parties and so on. I stress the need for everyone to be careful while we relax and participate in activities involving alcohol or recreational drugs. Now with the legalization of marijuana, it is legal to use marijuana in these gatherings. Please be careful out there and be aware that you can get an OUI for abusing marijuana as well.

As I said in the past, you are welcome to call or stop at any time you have concerns or questions. I would also like to take this opportunity to thank Town Manger Donna Turner and the Washburn Council for being so supportive of the Washburn Police Department.

The Washburn Planning Board finished its final review and subsequent approval of the Whispering Pines Subdivision on Route #164. The answer is yes. Another one is for a porch or deck, and the answer is yes for that as well. ## **Grounds and Maintenance Department**

As in years past, when summer starts there is a lot of grounds work and cemetery plot mapping to do. Like every year the outside work starts long before school gets out and ends long after school goes back in. We have roughly 18 properties we work on, including the 5 cemeteries. I want to thank Roger Hewitt for his work during the spring and the fall. Roger always takes a lot of pride in his work and it shows. When school was released for summer we had Patrick Saucier and Aidan Churchill come on board, and they worked through the summer for the town. I want to thank them for their hard work through a very hot summer. They did a great job. We had 42 burials last summer which translates to a lot of research and mapping.

In closing I would like to thank Donna and the council members for their support throughout the year. Thank you.

#### PARKS AND RECREATION DEPARTMENT

Another year has come and gone very quickly, and with that being said, there were a variety of programs for all ages that were offered throughout the year.

During the winter months I teamed up with the after-school program and we provided crosscountry skiing and snowshoeing. Basketball was offered for children in grades 1-6. Grades 5-6 competed in games against surrounding communities. Each team participated in the County Tournament with the boys being held in Caribou and the girls in Presque Isle.

Another program that was offered was the Basketball Hot Shot Competition. Thank you to Mr. Shea for allowing me to hold the local competition in his Physical Education classes. The top three girls and boys in each age division competed in the regional competition that was held at the Caribou Wellness Center.

During the spring time there was indoor soccer for children in grades 1-6. This program went for six weeks. There were movies and arts and crafts offered weekly to children in grades 1-4.

During school vacations the children partake in a variety of field trips such as roller skating at Melody Roller Rink in Caribou, ice skating at the Forum in Presque Isle, bowling in Presque Isle, dodgeball at the Ashland Rec Center, mini golfing at Goughan's Farm, snow tubing at Big Rock, and hiking at Mantle Lake and Haystack.

Our summer program staff consisted of Kolbie Churchill, Chelsea Hobbs, Derek Cruz, Ben Turner and Parker Corey. The programs that were offered were t-ball, minor league baseball, major league baseball, arts and crafts, cooking, basketball, soccer, track and field, and swim lessons at Mapleton Outdoor Pool. Every Friday during the six-week program the children had the opportunity to attend field trips. The trips that were offered were: Golfing at Goughan's Farm, Splash Pad in Presque Isle, swimming at Portage Lake, and hiking at Haystack.

During the fall there was soccer for grades K-6. Grades K-2 worked on developing their skills through a variety of drills and fun games. Grades 3-4 experienced playing against other communities such as Easton, Mars Hill and Ashland. The 5-6<sup>th</sup> traveling team participated in round robins each Saturday for six weeks and ended with the County Tournament that was held in Van Buren.

There was ornament making at the rec. center during the holiday season. Each child had the opportunity to make four ornaments to give to either a family member or friend.

There is a very active senior citizen group. We meet once a month at the Recreation Center to have lunch or breakfast. In August, we have made it a tradition to invite Easton and Ashland recreation departments for a barbeque at Thomas Brewer Park.

## **HIGHWAY DEPARTMENT**

As mentioned in the Manager's letter our biggest project last year was the sand/salt shed. We now have one building large enough to house all of Washburn and Wade's sand/salt under one roof and in one central location for all roads. This was a large undertaking and one that has turned out well. This building is 40' x 146'. Between the Right of Way of the ATV Trail and the Right of Way of the Road, we had just enough room for it. The Rubb Company has its own block system that hooks this entire building together. Each block weighs 12,000 with rods and brackets tying each together. This site and building were both approved by DEP improving our carbon footprint. This building allows us to keep the sand/salt cover so it no longer leaches into the ground, giving us a stronger mixture from the beginning to the end of the season. This was a joint venture between Washburn and Wade so the cost was covered by both towns. The cost of the building itself was \$366,000 with additional money needed for ground work, pavement inside the building and electrical. No additional tax money was needed to cover the cost of this building. Funding was primarily through ARPA funding through the government with additional money needed taken from the Sand/Salt expense lines. This building is constructed to withstand winds up to 105 mph, and snow loads of 110 pounds per sq. ft.



## **HIGHWAY DEPARTMENT**

Besides the sand/salt shed, a considerable amount of paving was done to upgrade more of the roads. We were able to do Riverside South, Clark Street, Churchill Street, Garage Drive and more of the Cross Road. There was also the many tons of cold patch that was placed in pot holes, culverts replaced, ditching, etc. The crew also spent a great deal of time last summer on a clean up at the Highway garage. What a great job they accomplished with this.

With this year, came the combining of the Washburn and Wade highway departments. Financially this is working well for both towns. They all pitch in together to help each other wherever that help is needed.

The Highway Department also purchased a new 2022 Chevrolet 5500 Series plow truck with sander unit. This truck has proved to be a great asset for cleaning the streets in town. There were a few bugs that needed to be worked out but we have those taken care of. This truck will also be of great use for many of the jobs that are done in throughout the year, not for just plowing. It seems that we have purchased a lot of new equipment in the past five years but everything now is up to where it should be. Now will come a routine of swapping trucks in and out to keep them as up to date as possible.

The MDOT sidewalk project is going to get underway this summer. This is going to be quite an extensive project and will cause quite a bit of turmoil in town before it gets better. Please try to be patient with everything as this gets taken care of. The majority of the work will be done in 2024 but there will be a start to it this summer.

The crew has a lot of projects lined up for the upcoming summer so when you see them out and about please slow down and use caution.

This has been a great year for our Washburn Memorial Library. We increased in our patron numbers as well as the overall number of program/event participants. We've continued our regular programming into 2022, along with adding new events, such as a Scholastic Book Fair, Chewonki Natural History Presentation, Senior Yoga & Craft Class, Seed Library, and our biggest event of "The Festival of Books & Baskets" during August Fest.

## **DIRECTOR'S REPORT**

- Total Patron # annual count = 3,650 (# of Adults = 2,947 / # of Children = 703)
- **Total # of Programs/Events** held = 103
- **Total # of Program/Events participants** = 3,010 (# of Adult participants = 2,000 / # of Children participants = 1,010)

## 2022 LIBRARY HIGHLIGHTS

- New Events: Seed Library and Gardening Resources (April September), Scholastic Book Fair, August Fest Basket Raffle Fundraiser, Chewonki Natural History Presentation, Book Gift Giving Tree, Blind Date with A Book, and more!
- August Fest: Local Author signing event (Bev Knowles) and *Festival of Books & Baskets* Total participants = **280** total participants (190 adult & 90 children).
- Wellness Wednesdays (post reach): Book reviews (videos) on wellness related resources, average # of people reach per post is = 422 people.
- **Teatime Book Club:** Cara holds a monthly meeting for book club participants. The average # of participants = 8 per month.
- Monthly Craft Class & Kits: Each month we offer a craft class & kit. We have an average of 20 people join us for these classes= 20 participants per month.

The tag issued with each license must be securely attached to a collar and worn at all times by the dog for which the license was issued. All dogs registered after January 31<sup>st</sup> are subject to a late fee of \$25.00, in addition to the license fee.

#### **KENNEL LICENSES**

When the number of dogs or wolf hybrids kept over 6 months of age does not exceed 10, the fee for licensure of the kennel is \$40.00 and, in addition, \$2.00 for each license as a fee for recording and making the monthly report required by the department.

**ARTICLE 23.** To see if the Town will authorize the Town Council, on behalf of the Town, to sell, lease, and/or dispose of any real estate or personal property acquired by the Town for non-payment of taxes or other Town bills thereon, at such price and under such terms and conditions as the Town Council deems advisable, and to negotiate and execute any and all documents necessary to accomplish any such transaction.

**ARTICLE 24.** To see if the Town will vote to authorize the Town Council, on behalf of the Town, to sell, lease, and/or dispose of any Town-owned property, either real estate or personal property, at such price and under such terms and conditions as the Town Council deems advisable, and to negotiate and execute any and all documents necessary to accomplish any such transaction.

**ARTICLE 25.** To see if the Town will authorize and instruct the Town Council to apply and charge all overdrafts in the Town Officers Report for the fiscal year ending on or before January 31, 2024, which overdrafts are not to exceed 7.5% of the original department Appropriation total without approval of a Special Town Meeting.

**ARTICLE 26.** To see if the Town will fix a date when taxes shall be due and payable and set a rate of interest to be charged on taxes unpaid after said date. Tax bills shall be due and payable upon presentation with a **2%** discount for payment within 30 days, and interest shall be assessed at the rate of **8%** as of November 1, 2023, until paid. Advance payment of estimated taxes shall be accepted before commitment, and no interest shall be paid for unsolicited advance payment or overpayment of estimated taxes.

**ARTICLE 27.** To see if the Town will vote to authorize the tax collector to enter into a standard agreement with taxpayers establishing a tax club payment plan for property taxes, whereby: (1) the taxpayer agrees to pay eleven (11) specified monthly payments to the Town based on his/her actual tax obligation for current year property taxes; (2) the Town agrees not to charge interest on timely payments made pursuant to the tax club agreement; (3) the Town authorizes the tax collector to accept tax club payments for current year taxes which may be made prior to the tax club payment due date; (4) the tax club agreement is automatically terminated if a monthly payment is not made, and the taxpayer then becomes subject to the same due date(s) and interest date(s) and rate as other taxpayers who are not participating in the tax club; (5) only taxpayers who do not have outstanding tax obligations for prior tax years are eligible to participate in the tax club program; and (6) taxpayers wishing to participate in the tax club for a particular property in the current tax year shall enter an agreement with the Town by a deadline determined by the tax collector as noted on the current tax bill.

**ARTICLE 28.** (Under Estimated Income) To see if the Town will vote to accept money from the Maine Department of Transportation for Local Roads Assistance Funds in the estimated amount of \$31,000.00 for the purpose of road maintenance and repairs.

**ARTICLE 29. (Under Estimated Income)** To see if the Town will vote to accept funds from the State of Maine provided by the Maine State Legislature the following funds (excluding Local Roads Assistance contained in the previous article) are:

- 1. State Municipal Revenue Sharing
- 2. General Assistance Reimbursement
- 3. Veterans Exemption
- 4. Tree Growth
- 5. Homestead Exemption
- 6. BETE Reimbursement

**ARTICLE 30.** To see if the Town will vote to authorize the Town Officers to spend an amount equal to 2/12ths of the 2023 budget from February 1, 2024, through March 31, 2024. This will allow the Town to operate during the two (2) months prior to the Annual Town Meeting.

**ARTICLE 31.** To see if the Town will vote to use **\$90,252.00** in Surplus Funds as part of the grant match for the MDOT Sidewalk Project.

**ARTICLE 32.** To see if the Town will vote to use up to **\$100,000.00** in Surplus Funds as grant match for possible CDBG funding for the parking lot needed between the Library & Store.
