GREETINGS:

In the name of the State of Maine, you are hereby required to notify the voters of the Town of Washburn, in said County of Aroostook, qualified by law to vote in the Town affairs, to meet at the WASHBURN ELEMENTARY SCHOOL in said Town on MONDAY, THE 17th DAY OF JUNE, 2024, A.D. AT 6:00 O'CLOCK IN THE EVENING (Eastern Standard Time), then and there to act on the following articles to wit:

ARTICLE 1. To choose a Moderator to preside at said meeting.

ARTICLE 2. Shall the Town of Washburn (1) approve the construction and equipping of a municipal building project to house various municipal services, including engineering, design, and any other related costs thereto (the "Project"), (2) appropriate a sum not to exceed \$5,000,000, and (3) authorize the Chair of the Town Council and Treasurer to issue general obligation securities of the Town (including temporary notes in anticipation thereof) in an aggregate principal amount not to exceed \$5,000,000, plus any additional premium, and delegate to the Chair of the Town Council and the Treasurer the discretion to fix the dates(s), maturity(ies), denomination(s), interest rate(s), place(s) of payment, call(s) for redemption, premium(s), form(s) and other details of said securities on behalf of the Town and to provide for the sale thereof.
